Take Action: Get Certified as a Woman-owned Small Business (WOSB) for Government Contracting Opportunities

Join the Urban League of Louisiana for ***"Take Action: Get Certified as a Woman-owned Small Business (WOSB) for Government Contracting Opportunities"*** on Tuesday, January 7, 12:00pm-2:00pm, virtually.

The Women-Owned Small Business Federal Contract Program (WOSB Program) is designed to provide a level playing field for women business owners. The federal government limits competition for certain contracts to businesses that participate in the WOSB Program. These contracts are specific industries where WOSBs are underrepresented. Some contracts are restricted further to economically disadvantaged women-owned small businesses (EDWOSBs). Getting certified as a WOSB Federal Contract Program participant makes a business eligible to compete for federal contracts set aside for the program.

During this session, small business owners will learn the benefits of the WOSB certification, eligibility requirements, and the certification process. This workshop will also provide participants with insights on how to best leverage their WOSB certification to access government contracting opportunities. Participants will also learn how to access the *"MySBA Certifications"* website - a new, upgraded single application for SBA federal contracting certifications.

The Disadvantaged Business Enterprise (DBE) Program was created to remedy past and current discrimination against DBE firms. The intention is to level the playing field for socially and economically disadvantaged individuals wanting to do business with the DOTD on U.S.

Department of Transportation federally assisted projects.

In order to comply with regulatory mandates, LADOTD collectively joined with the Louis Armstrong New Orleans International Airport, and the New Orleans Regional Transit Authority to develop and implement uniform procedures for DBE certification – the Louisiana Unified Certification Program (LAUCP). This program eliminates the necessity for DBE firms to complete multiple applications, as certification decisions are reciprocally accepted throughout the UCP membership in Louisiana.

During this session, attendees will **gain insights into the LAUCP DBE Certification program, including: eligibility requirements, understanding the application process, and leveraging your certification.**

The Consultant shall provide all personnel, equipment and software necessary to conduct on-site inspection of the construction, maintenance and operation of charging stations designated by DOTD and provide data collection and reporting to ensure adherence to the requirements delineated in 23 CFR 680, et seq. About the National Electric Vehicle Infrastructure (NEVI) Formula Program

Louisiana will receive approximately \$73M for electric vehicle (EV) infrastructure through President Biden’s Infrastructure Investment and Jobs Act (IIJA).

The Louisiana Department of Transportation and Development (LA DOTD) plans to administer the deployment of electric vehicle charging station infrastructure throughout the State. As part of the EV infrastructure deployment plan, the U.S.



Legislature has made National Electric Vehicle Infrastructure (NEVI) Formula Program funds available for expenditure by state transportation agencies. These funds will cover 80 percent of the EV infrastructure expenses with a minimum 20 percent state match covered by grant recipients. To disburse these funds, LA DOTD is developing a competitive grant program that allows for a phased approach to the buildout of electric vehicle supply equipment (EVSE) over five years that meets federal requirements of DC Fast Chargers within one mile of designated corridors.
