

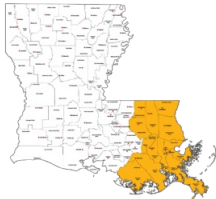




Interested in becoming an Entergy supplier?

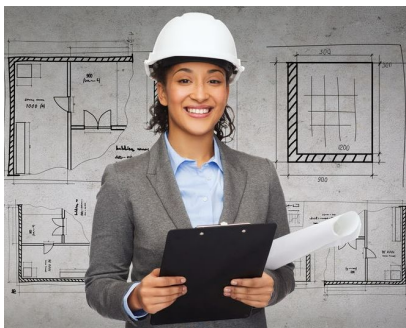

Applications Now Open for the Louisiana Contractors Accreditation Institute's Business and Law Seminar October 7 - November 13 | 6:00pm-8:00pm CST | Virtual | \$200



Registration is now open for the **Louisiana Contractors Accreditation Institute's (LCAI) Business and Law Seminar**, which provides small and emerging construction businesses critical information about construction management and business operations. The six-week course is a key component of Louisiana's nationally recognized training institute for construction professionals.

The course will take place **online via Zoom October 7 through November 13**, consisting of two-hour sessions twice a week on **Mondays and Wednesdays from 6 to 8 p.m.**

Registration began this week and will continue through Oct 4. A \$200 fee covers the cost of the course and materials. To register, visit OpportunityLouisiana.gov/LCAI-BL and click the **"Apply Now"** button.

The Business and Law Course is one of three LCAI programs offered each year and is designed for small and emerging construction businesses. Topics to be covered include:

- Bid process
- Contract management
- Estimating
- Equipment management
- Scheduling
- Occupational safety
- Risk management
- Financial and business management
- Bonding/access to capital
- Certifications and resources
- Entrepreneurship training



The Louisiana Contractors Accreditation Institute is a partnership between Louisiana Economic Development, Louisiana Community and Technical College System and the Louisiana State Licensing Board for Contractors.

Since 2016, more than 1,600 participants have graduated from LCAI seminars. Completion of this course does not grant exemption of any licensing or examination requirements from the Louisiana State Licensing Board for Contractors.
